# CARD PAYMENT SERVICE FROM INDIA (DEBIT / CREDIT / PREPAID CARD) STANDARD OPERATION PROCEDURE (SOP)

Due to some technical issues with NEPS switch, currently the NEPS integrated switch cards will not be working on OFF-US module. The cards will be on used ON-US module. Since the cards can be used in ON-US module only as of now, the withdrawal from ATMs/POS in India & Bhutan is also not possible. Hence, in order to provide services to the extremely needy people traveling to India, Prabhu Bank Ltd will provide alternate solutions for ATM/POS withdrawals till the current problems is resolved. A standard Operation Procedure is developed in line with the notice from Central Bank of Nepal.

#### STANDARD OPERATION PROCEDURE

- 1. The focal contact center will be Prabhu Bank Staffs in India. (Annex I)
- 2. The services are delivered in the following states of India
  - a. Delhi / Mumbai / Haryana / Gujarat / Hyderabad / Bangalore / Kolkata / Pune / Chennai
- 3. This service is available to the customers of NEPS integrated Banks only (Annex II)
- 4. Customer in India must contact the Prabhu Bank Staffs in India and visit to him/her in person along with the card (DEBIT/CREDIT/PREPAID CARD)
- 5. Customer must fill "Authorization to Make Payment" form (Annex III) duly signed along with Account Number, Card Number, Customer Name and Card Belonging Bank Name.
- 6. Prabhu Bank Staff in India shall send filled form to the PRABHU BANK LTD FINANCIAL MARKET (SALES) DEPT. (nisha.rajbanshi@prabhubank.com) (binda.adhikari@prabhubank.com) / WHATSAPP group "PRABHU CARD SOLUTION" for further processing with the respective banks.
- 7. Financial Market (Sales) Department will send the same to the respective banks Treasury Department for verification of Account Name / Account Number / Signature / Balance / Card Number.
- 8. Upon matching all, the respective banks shall debit the customer account and cover the payment to **PRABHU BANK LTD** account **(1205126041-000-524)** maintained with NEPAL RASTRA BANK through a confirmed Treasury Deal.
- Upon receiving confirmation and Treasury Deal is made, Financial Market (Sales) Dept. shall
  instruct the Prabhu Bank Staff in India via email / Whatsapp Group "PRABHU CARD SOLUTION"
  to make the payment to the customer in cash.
- 10. The limitation of amount shall be as per the ATM cash withdrawal limits.
  - a. Per Day withdrawal limit: up to INR 25000/- (as per POS withdrawal limit)
  - b. Per month withdrawal limit: INR 100,000/\*subject to approval from case to case basis on the limit enhancement request
- 11. As per NRB notice, there shall be no charge (FEE) for availing this service. (Both Customer and Bank to Bank).
