1. Agree to enroll myself with the 3D secure services as per the enrollment process shared by the bank.
2. Any deletions, additions, insertions or alternations to, or any unauthorized use of, online transactions by the cardholder.
3. Any misrepresentation or breach of representation or warranty made by the cardholder while using of online transactions,
4. Any breach of any covenant or obligation to be performed by the cardholder of the Terms and Conditions contained as incorporated in Visa debit card application and by availing the online transactions facilities by the cardholder. The cardholder agrees to pay any and all costs, damages and expenses, including, but not limited to, reasonable attorneys' fees and costs awarded against it or otherwise incurred by or in connection with or arising from any such claim, suit, and action or proceeding attributable to any such claim, or
5. All online transactions performed by cardholder should comply with Nepal Rastra Bank regulations and existing laws of the country. Should there be any transaction found performed against the policy, cardholder will be fully liable for such transactions.
